

**AMENDMENT TO THE
2014 ACTION PLAN COMPONENT OF THE
2010-2014 CONSOLIDATED PLAN FOR
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)
FUNDING AS PREPARED BY THE
CITY OF MIDDLETOWN
OFFICE OF ECONOMIC AND COMMUNITY DEVELOPMENT**

A. BACKGROUND

The City of Middletown Office of Economic and Community Development (OECD) submitted a final Action Plan Component to the 2010-2014 Five-Year Consolidated Plan to the U.S. Department of Housing and Urban Development (HUD) on November 7, 2013. A public review period was undertaken from October 2, 2013 through October 31, 2013. The following proposed allocations of Community Development Block Grant (CDBG) funding were made under the 2014 Action Plan:

Budget for the 2014 program year, based on the 2014 allocation and program income figures. The program income figures will be adjusted based on the actual amounts collected for 2014.

The Substantial Amendment guidelines contained in the City's Final Consolidated Plan for 2010-2014 requires that an Amendment be undertaken whenever the purpose, scope, location, or beneficiaries of a CDBG eligible activity is changed in a material way, such that the same is no longer consistent with the initial proposed activity contained within the applicable Action Plan when adopted subsequent to modification made thereafter.

B. AMENDMENT

The City of Middletown Office of Economic and Community Development announces that it will redirected an amount of \$75,000 in Program Income derived from Economic Development related activities in previous Program Years to the Section 108 Loan Guarantee Program to render payment to HUD on certain Section 108 obligations. The unanticipated reallocation of Program Income to cover this HUD Section 108 obligation has not impacted the Program year 2014 allocation of CDBG resources since the payment was made out of Program Income derived from CDBG activities unrelated to the 2014 Program Year.

The Amendment to the 2014 Action Plan involves adding and allocating an increase in Program Income budgeted to the Economic Development Project and Unplanned 108 Repayment Activity, in the amount of \$75,000. Attachment 1 summarizes the relevant changes to the originally submitted 2014 Action Plan. Attachment 2 features revised Schedule 3C tables indicating the amended allocation to the projects included in the scope of the Amendment.

C. PUBLIC PARTICIPATION

A public comment period on the Amendment was conducted beginning on June 21, 2014 and will end on July 21, 2014.
